
DECREE No. 2019/5861 /PM OF 28 NOV 2019 to appoint officials at the Ministry of Social Affairs

THE PRIME MINISTER, HEAD OF GOVERNMENT,

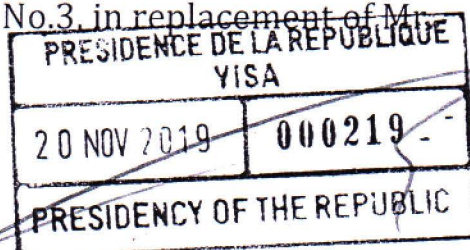
